

## WINTER YURT RESPONSIBILITIES



In reserving a YURT in North Fork Park, you will be required to sign a licensing agreement with Weber County. This agreement will be sent to you via email after your reservation is complete. You must sign the agreement and either bring it with you when you check in or email to manager@ogdennordic.com.

The following is a list of the responsibilities agreed to when reserving the Yurt.

- A. Yurts MUST be accessed by snowshoes, skis or fat bike. Regardless of the mode of access, all 'rules' for trail use must be followed. You are responsible for knowing and adhering to ALL Ogden Nordic 'rules'. View the website activity menu for details.
- B. Trail passes for use of the trails for skiing/snowshoeing or fat biking must be purchased for all yurt visitors who are not season pass holders.
- C. ALL supplies must be taken in by users (no snowmobile assistance will be provided to schlep stuff). See a printable list of suggested supplies at: <a href="https://oceny.com/yurt-more-info">Oceny.com/yurt-more-info</a>.
- D. Maximum occupancy is 6. HOWEVER, each yurt has one double and two single bed platforms accommodating 4. If you have 5 or 6 occupants, please plan accordingly.
- E. No pets allowed unless certified service dogs
- F. No smoking in the yurts
- G. No open flame cooking devices will be used in the yurt all cooking must be done on the wood stove
- H. Ogden Nordic or Weber County Parks & Rec will not be responsible for valuables
- I. Trash: pack it in, pack it out \*\* failure will result in loss of part of deposit\*\*
- J. No trash in restrooms
- K. No washing dishes in rest rooms
- L. No outdoor camping
- M. Users are responsible for clearing snow during their stay.
- N. Users must use wood provided for stoves no cutting of trees
- O. Users must sweep the yurt upon leaving and clean out stove as directed before checking out
- P. Users are responsible for restroom key (each yurt will have a key to restrooms)
- Q. Users are responsible for following all close up/cleaning steps and trash removal instructions which will be posted in the yurt.
- R. Users will observe quiet hours after 10 pm.
- S. Users understand the trail grooming equipment will come through on the trails in the middle of the night during their stay.
- T. Cancellation Policy:
  - 30+ day prior to reservation: full refund
  - 2 weeks 30 days prior to reservation: ½ refund
  - Less than 2 weeks prior to reservation: no refund
- U. Date/Duration Change Policy:
  - 30+ day prior to reservation: no change fee
  - 2 weeks 30 days prior to reservation: \$75 change fee
  - Less than 2 weeks prior to reservation: Changes unavailable, follow cancellation policy
